## Linking Individuals to Resources

We've come a long way since the formation of the MOBIUS Consortium back in 1998. Through the dedicated efforts of our member institutions and MOBIUS office staff, we've come to link numerous individuals to the resources they need to be successful.

Through the years, the number of persons benefiting from MOBIUS has increased substantially. Bill Rodgers of Missouri River College estimates in 2007, their institution sent out 5,663 materials and received 3,539 items. Between 2006 and 2007 they experienced a 28 percent increase in the amount of items sent and a 12 percent in the amount of items received. These statistics represent significant growth and similar numbers are reflected throughout many other of our member institutions. Patrons consistently are able to find materials through MOBIUS that they are not able at other local libraries. I'm confident that through your support we'll continue to grow in the future.

**In an effort** to improve training opportunities, the MOBIUS consortium office has initiated a process of reviewing all training documentation, said Jim Dutton, software support analyst expert for MOBIUS.

“We have started with the circulation and cataloging documents and have solicited volunteers from a self-identified group of staff including MOBIUS member libraries who are interested in training issues, MOBIUS Access Advisory Committee and the MOBIUS Catalog Design Advisory Committee,” Dutton said. “We asked for their feedback and have begun cataloging the results.”

Based on responses, the group has revised documents and is in the process of improving upon the system.

# Information Resources

## MAROON – Missouri’s Available Resources on Online Networks.

In Fall 2000 the newly formed MOBIUS Electronic Resource Advisory Group (MERAC) decided that one of its first tasks was to gather information on what electronic resources are being subscribed to by MOBIUS members. One of the main reasons for doing this was to see if there could be any advantage to buying resources for the consortium. This database was accessible on the MOBIUS website.

The original name of the database was Missouri’s Archived Resources on Online Networks. The name was soon changed to Missouri’s Available Resources on Online Networks. The database was patterned after MERLIN’s RED database which compiled similar information for the University of Missouri’s four campuses. Information stored in MAROON included subscribing institutions, the MOBIUS clusters, electronic resources, vendors, costs to the institution, types of access to the resources, estimated level of use, and the dates of the subscription periods. Full access to this information was limited to the submitting institution and MOBIUS’ Electronic Resource Staff. MOBIUS members could view general information in MAROON but not information private to an institution such as cost. It was the responsibility of

each library’s Electronic Resource representative to keep MAROON updated.

ERMA – affectionately named ERMA this is an Electronic Resource Management (ERM) database. ERMA is an access database that stores electronic resource information for use by the MOBIUS staff. Contained in ERMA is vendor, resource, and licensing information, library IP addresses, and invoice costs. This database is stored on the MOBIUS server.

With the need to move the MOBIUS website to a new server there was the need to recreate MAROON. It was decided to incorporate ERMA into the new MAROON. Not having the expertise in-house an outside contractor was hired to write the new program. Presented with the first “draft” MERAC members vetted the new program last fall suggesting some improvements. Essentially, MAROON is finished. The outside contract sent MOREnet the files for the program at the beginning of the year. We are waiting for MAROON to be loaded to the new server. No timetable has been established for that. As soon as it is available the Electronic Resource representatives can start to bring it up-to-date.

## Task Force on Financial Planning

The Task Force on Financial Planning met on April 10 and plans to hold its next meeting on May 8. In the time between these meetings the task force will be asking each member library to report current statistics on the size of their collection, the size of their portion of the patron database and the amount of circulation they do in a year, said committee chair, Sharon McCaslin.

“These statistics, along with others, such as their number of licenses and their use of the MOBIUS system will be used to create a relational spreadsheet,” said McCaslin. “From the resultant proportions and statistics we hope to develop a formula which is both fair and as feasible as possible, given the lack of state support.”

The Task Force is also charged with developing various other structures, including a plan for building reserves, a method for relaying the maintenance of additional software to those who purchase it, and a mechanism for providing extra-cost services beyond the normal and expected services. Some of these tasks will take longer than others, but it is hoped that this work will be nearly completed by the September Council meeting.

Other members of this task force include: Shirley Baker, Sharon Bostick, Annie Busch, Valerie Darst, Beth Fisher, Neosha Mackey, Loretta Ponzar, and Julia Schneider. The group encourages comments and suggestions from the

Council members.

## Task Force on Strategic Planning for the period of 2009-2013

Charged with developing the upcoming strategic plan, the group is composed of members from diverse areas of the consortium according to chair, Valerie Darst of Moberly Area Community College.

“The group’s membership was chosen not to ‘represent’ units or constituencies, but rather to bring diverse perspectives to the planning process,” said Darst. “Most generally, we’re charged to engage the MOBIUS community and diverse stakeholders in a thoughtful discussion of where the consortium is, where it should go, and how it should get there.”

Darst says the group will work closely with the membership to design the planning process and to craft a coherent, forward looking, and realistic plan.

## Task Force on ILS Software

The MOBIUS ILS Task Force recently wrapped up efforts to review ILS enhanced search software. The group was charged to review and

develop information, possibly including a request for proposal, on ILS enhanced search software, review vendor’s offerings and recommend a proposed solution to the MOBIUS Executive Committee and Council.

“The task force identified mandatory and optional features in any software we should acquire and compiled a list of questions to ask vendors based on discussions of features we wanted in our enhanced ILS search software,” said committee chair Judy Fox of Washington University. “Conversations were held with several vendors and the task force recommended request for proposals be sent to three vendors we identified as coming the closest to meeting our functional requirements if funding becomes available.”

The group submitted their report to the Executive Council on January 15, 2008.

## 1st Choice Tracking System

Formed in November of 2007, the MAAC 1st Choice Tracking System subcommittee has been charged with distributing information regarding the system throughout MOBIUS libraries, creating easy-to-understand directions on how to use the system, becoming functional experts for MOBIUS members and adding best practices for tracking the contents of the bags to the MCO website.

"Directions for the 1st Choice Tracking System will be posted in both PDF and PowerPoint formats shortly," said committee chair Bonnie Sanguinet. "We intend to use the Springfield

Green procedures for tracking books within bags and post them on the web page as an example of best practices."

Sanguinet says the subcommittee is working closely with Paul McGrath to ensure they are informed of the progress of the 1st Choice Tracking System rollout. Scanners have been purchased and are currently being programmed and distributed to all MOBIUS libraries. The 55 libraries served through Kansas City and St. Louis started using the tracking system in mid-February. The other 22 libraries served out of Columbia and Springfield should be operational by the end of March.

## Courier Bags

Thanks to an increase in book requests by users, MOBIUS will purchase additional courier bags. The MOBIUS Access Advisory Committee in April approved a new bag design that is of heavier fabric and more weatherproof compared to the earlier bags. 2000 bags are in this year's order, with 1000 per year after that. The bags should arrive shortly after the start of the fiscal year.

# Missouri Library Advocacy Day



**Each year the Missouri Library Association** sponsors Library Advocacy Day. It's an opportunity for librarians, trustees, and library supporters to join together and remind legislators about the importance of all types of libraries to the citizens of Missouri. The day begins with updates from a variety of people regarding legislative issues that are important to libraries. The afternoon is open for individuals to make appointments to speak with their legislators. The evening includes a buffet dinner at the Jefferson City Country Club. This is an excellent time to casually interact with legislators, all of whom are invited to the dinner.

Depending on your institution, advocacy can be somewhat tricky in an academic library setting. It's important to learn what is acceptable on your campus and work within that framework. Is it permissible to meet with your institution's lobbyist? Is it preferred that library legislative concerns are funneled through a specific office or person on campus? These are questions that we should each explore. It's important that even if legislative contacts are handled by others on our campuses, we are aware of issues impacting all Missouri libraries as well as those issues that impact MOBIUS directly.

We should be able to clearly articulate the importance of MOBIUS to our institution's and Missouri citizens. To begin this process, Outfront Communications worked with a group of MOBIUS Executive Committee members to develop the 60 Seconds on MOBIUS handout which includes a map identifying our institutions on the back. This literature was distributed to legislators by those attending Library Advocacy Day in February. It's an important first step in the conversation we need to have to help MOBIUS continue to grow and evolve.
